

Terms and Conditions of Use of GoToCollegeFairs, LLC (“Terms and Conditions”)

GoToCollegeFairs, LLC (“we,” “us,” or “our”) expedites the exchange of information between students and colleges, universities, organizations, and sponsoring organizations at college fairs, as well as the sponsoring college fair organization.

Without waiver of binding arbitration as set forth herein, any controversy, claim, action, proceeding, or dispute brought in court shall be governed by and construed in accordance with the law of the United States of America and you hereby irrevocably submit to the exclusive jurisdiction of the courts of the Commonwealth of New Jersey in the County of Mercer in any controversy, claim, action,

proceeding or dispute arising from your use of the Website or related services, including, without limitation, these Terms and Conditions.
